



Terms and Conditions Parking du Centenaire – VILLARS


1. Drivers use the Parking du CENTENAIRE at their own risk. The COMMUNE D'OLLON declines all responsibility when it comes to theft, as well as any damage caused to vehicles during the time they are parked.
2. The ticket machine at the entrance delivers a ticket that allows users to exit the parking within 15 minutes. Past that time, one must compulsorily present the ticket at the automatic payment machine.
3. The ticket received at the entrance must be kept by the driver until exiting the parking. Before regaining one's car the user **MUST** present the ticket at the checkout payment machine, found at the pedestrian entrance, to pay the parking fee.
4. Should the parking ticket be lost, a one-off tax will be requested to receive a ticket to exit the premises. The amount of this tax may be subject to change.
5. The tariffs are displayed on the payment machine which is at the entrance of the parking. These prices may be subject to change.
6. The automatic payment machine accepts payments by cards, banknotes or coins.
7. Drivers that desire to obtain an annual ticket to access the parking are kindly asked to enquire at the COMMUNE D'OLLON. The annual cost of this subscription is fixed at CHF 1'000.--. The access to the parking does not guarantee a parking space. A quota of 20 annual subscriptions has been fixed.

The Municipalité reserves the right to change this quota, as well as the tariff mentioned above.

8. The possibility to purchase an annual subscription is open to any natural person or legal entity, with the exception of taxi companies.
9. Annual subscriptions will be automatically renewed. Terminated subscriptions will be offered to those present on the waiting list.

10. The maximal duration of parking is 7 days, except for those who hold a subscription. In case of violation, the Municipalité reserves the right to immobilize the vehicle.
11. Parking users are bound to:
 - a. Conform to the present regulations;
 - b. Conform to the instructions given on the traffic and road signs that are found within and outside the parking. We draw your attention to height limits (max. 2.10 m.) and speed limitations.
 - c. Exit the parking premises straight after having parked. The vehicle must have the handbrake on and must be in gear. The ignition key must be removed and the doors and boot locked.
12. It is prohibited for users to:
 - a. Store vehicles in the parking with no number plate;
 - b. Do any kind of work on vehicles within the parking;
 - c. Store fuel or any inflammable objects;
 - d. Park vehicles whose motor, petrol tank, radiator, sump, etc., are not hermetic;
 - e. Store any object, waste or other substance in the parking, except in bins and ashtrays, that are likely to be detrimental to the parking's order and cleanliness;
 - f. Try engines or have them run for no reason.
13. The user is requested to announce immediately any damage, that one could have caused to third-parties' vehicles or to the parking's infrastructures, to the COMMUNE D'OLLON. The vehicle's owner will be held responsible for all damage caused by themselves, or by the people to whom the vehicle was entrusted, caused by any object or thing belonging to the user or person entrusted, to property in the parking or to that of other users.
14. No recourse is possible when it comes to risk or damage, resulting from fire or theft, with regard to a vehicle or its contents within the premises of the parking.
15. Complaints are to be addressed in writing to the COMMUNE D'OLLON.
16. The current regulations will come into effect on 1st January 2018.
17. Place of jurisdiction: Ollon.
